

Privacy Policy

1. Your Consent

2. Your Personal Information

a. Collection

Only information you provide us with will be collected. For example, should you email us your email address will be collected so we may correspond with you, or should you order from our website the information provided will also be collected.

b. Storage

Any data that we collect is stored through Wix.com's data storage on secure servers behind a firewall. All direct payment gateways offered by Wix.com and used by us adhere to standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover. PCI-DSS requirements help ensure the secure handling of credit card information by our store and its secure providers.

c. Use

Information that we collect and store is used for the following reasons:

- i. To provide and operate the products and services rendered;
- ii. To provide our users with customer assistance and technical support;
- iii. To contact consenting visitors or users with general service-related notices or promotional messages;
- iv. To comply with applicable laws and regulations.

d. Disclosure

June Tailor does not sell any obtained stored information and does not disclose information to any third-parties unless complying with applicable laws.

3. Cookies

Cookies are the small pieces of data that are stored on website visitor's browser. Most cookies are used to record which settings and actions a user has selected or taken on a given website. Our website uses only essential cookies like the ones explained. Although you may choose to turn these cookies off at any point through your browser settings we do not recommend this as our website will not function properly.
